You should read this completely. Your registration will NOT be accepted unless the Event Waiver is signed as read and accepted.

ACCEPTANCE OF ENTRY CONDITIONS, WAIVER RELEASE / INDEMNIFICATION AND STATEMENTS OF INTENT DECLARATION WARNING:

This is a legal document which affects your rights:

A contract in the terms set out below between Riviera Triathlon Club Inc ("RTC") who are the organisers of (The "Event") and the intended competitor. It shall be deemed to have commenced on the acceptance by Riviera Triathlon Club of the intended competitor's completed application to compete. In consideration of and as condition of acceptance of my entry in the Event:

1. I acknowledge that competitive triathlon involves the real risk of serious injury or even death from various causes including over exertion, equipment failure, dehydration, accidents with other competitors, spectators or road users, and course or weather conditions to name a few.
2. I understand that I should not compete in this event unless I have trained appropriately and my physical condition has been verified by a medical practitioner, who has not advised me otherwise.
3. By competing, I accept all risks necessarily flowing from my participation that could result in loss of life or permanent injury. Accordingly, I release all people associated with the conduct of the event from, and will indemnify them against, all liability (including liability for their negligence) for all injury, loss or damage arising out of or connected with my participation in this event. For clarification, the people released include officials of the Riviera triathlon Club Inc., its contractors and event organisers, promoters, sponsors, managers, government and public authorities, Triathlon Victoria and volunteers including event medical and paramedical personnel and shall operate whether or not the loss injury or damage is attributed to the act or neglect of any one or more of them.
4. I, for myself, my heirs, my executors and administrators hereby waive and release all and any claim, right or cause for action which I or they might otherwise have for, or arising out of loss of life or injury, loss or damage or any description whatsoever which I may suffer or sustain in the course of, or consequent upon, my entry or participation in the said event. This release and indemnity continues forever and binds my heirs, executors, personal representatives and assigns.
5. I consent to receiving any medical treatment that event organisers think desirable during or after the event.
6. I consent to event organisers using my name, image and likeness, before during or after the event, for event promotional broadcasting or reporting purposes in any media.
7. I understand that the information that I have provided herein may be included in a Triathlon Australia database and may be disclosed on occasions to the Australian Institute of Sports Commission, State Institutes and Academies of Sport and the Australian Sports Drug Agency. I also understand that information of a biographical nature including my name, date of birth, home state, results, career highlights and interests may be released to the media in response to general requests.
8. I understand that compulsory insurance cover affected for participants in this event may not cover me for all injury, loss or damage sustained by me, eg. Heart failure and muscle fatigue
9. The sanctioning process and safety precautions undertaken by the event organisers (such as course supervision, race safety briefings, bicycle and helmet safety checks) are a service to me and other competitors but are not a guarantee of safety.
10. I am fully responsible for the security of my personal possessions at the event.
11. My registration is not transferable to other people. If I am unable to compete, or if the event is cancelled, my registration fee is non-refundable.
12. I have attached to my entry form details of any medical or physical conditions from which I suffer that might affect my performance or be relevant if medical treatment is needed.
13. I agree to abide by all race rules and directions issued by the event organiser. I also agree to abide by all the Rules of Triathlon Australia which relate, in part, to safe and fair sporting practice.
14. I certify that I am 18 years of age or older and I have read this document and fully understand it.
15. If you are under 18 years of age on the date of the Event, a parent or guardian must accept these terms and conditions and acknowledge by signing the declaration below.
16. The Riviera Triathlon Club acknowledges and respects the privacy of individuals.
17. The information that is collected is for processing your registration. The intended recipient of this information is the Riviera Triathlon Club.
